Communications Group

Buddy calls completed (29/77)

- Suggestion that LPC Members visit Buddies – good idea – to introduce ourselves and ascertain what their preferred contact method is. Time in August to do this.
- The comms group focussed on draw of training at AGM supporting November review point: QPs, HLP evidence & visits, Patient Safety logs, asthma referrals, sharing best practice, Hema & Jyoti to talk on respiratory/ACT, CHS talk,
- The group had spoken about repeat Rs (POD, HW Coventry), and the potential of eRD in managing workload in the pharmacy while GPs retain control. Use in Walsall is low, engage LMC?? Together with 'flu service.....

CCG

Scoping Rx ordering options, inclu POD, stopping CP ordering, promoting online ordering. Practice views sought > improvements.

Incorrect Qs on Rxs – vigilance, request practice pharmacist be alerted, check EPS Claim message/endorsement.

Branded Generics – LPC members reported significant incr in prices of drugs which had been subject of switches.

Hema reported the MECS service is to be extended for 3 months for review/evaluation.

PF 16 and over 3 visit/annum cap, emphasis on self-care to support GP agenda (limit Rxs for Ibuprofen, Paracetamol, Vit D) and prescribing incentive scheme. Record on PharmOutcomes (old tab has to remain to allow 3-month data entry period).

PNA Review Pharmacies requested to log hours on Pharmoutcomes, qs include core and supplementary hours, NHSE have no record of these.

Healthy Start – pharmacies requested to consider this service to eligible patients, no fee, agreed to publicise on website.
